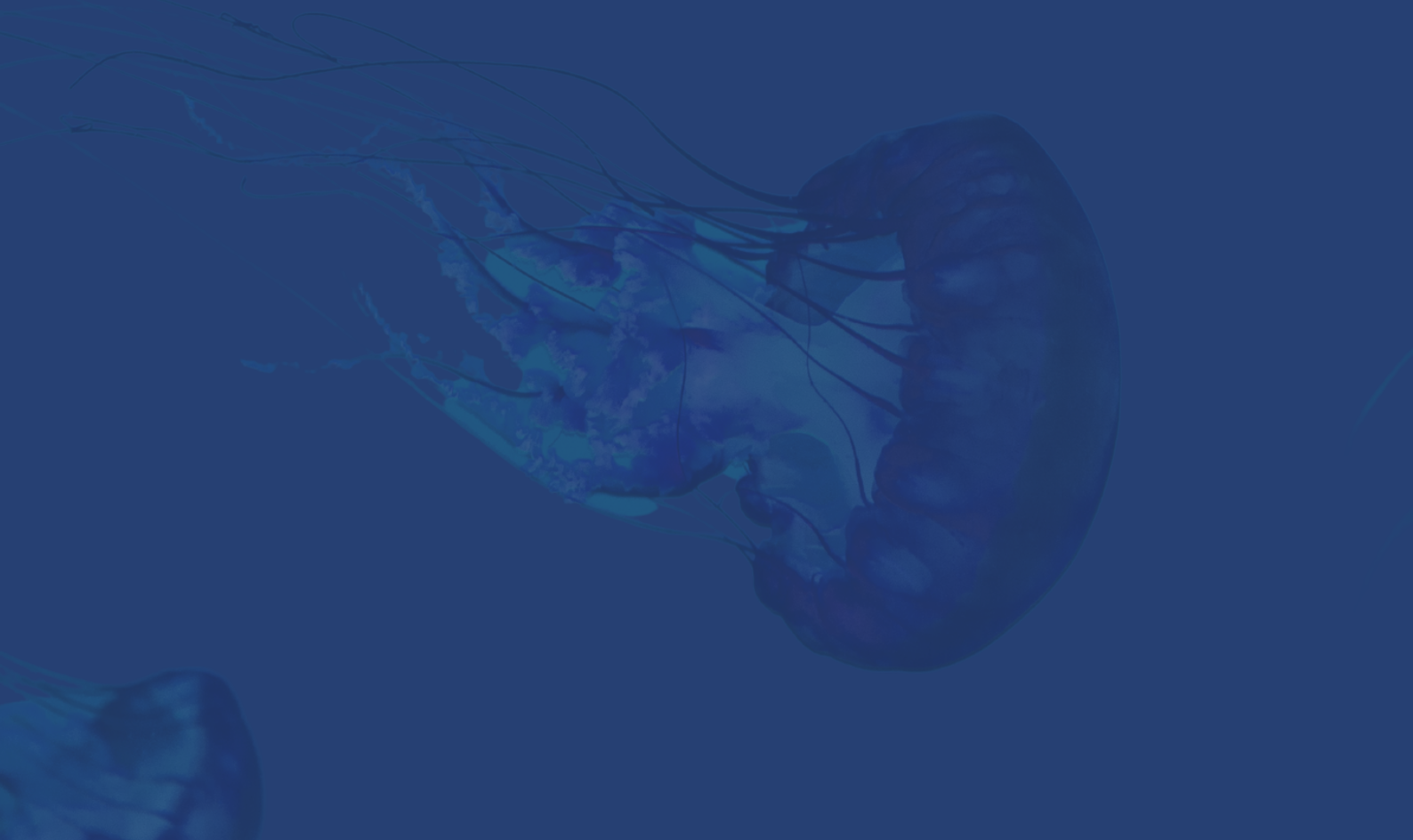

Our vision is to create a vibrant North Sea Region by helping innovators get their game-changing ideas off the ground.



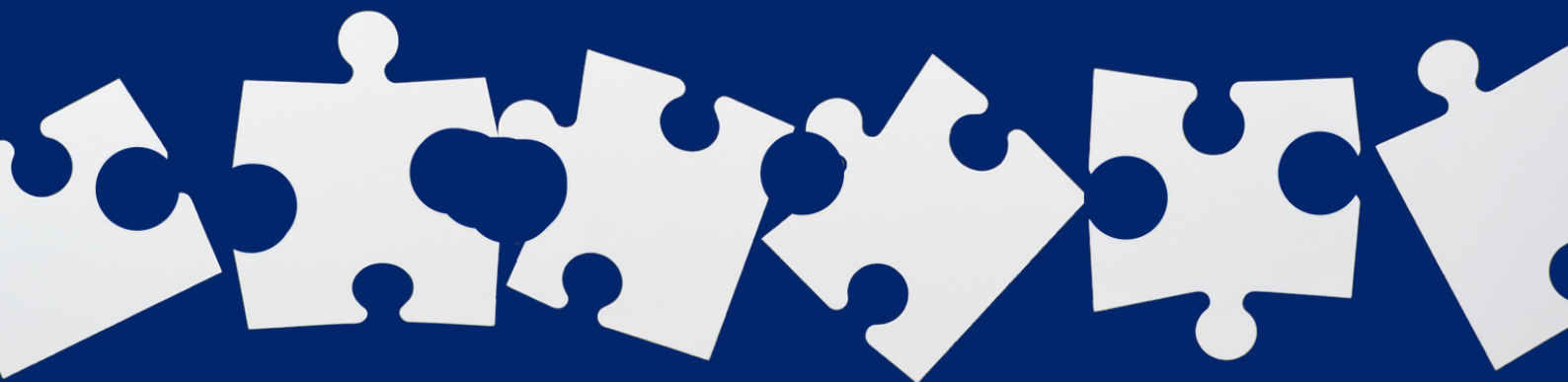
Find the right spot for your project idea

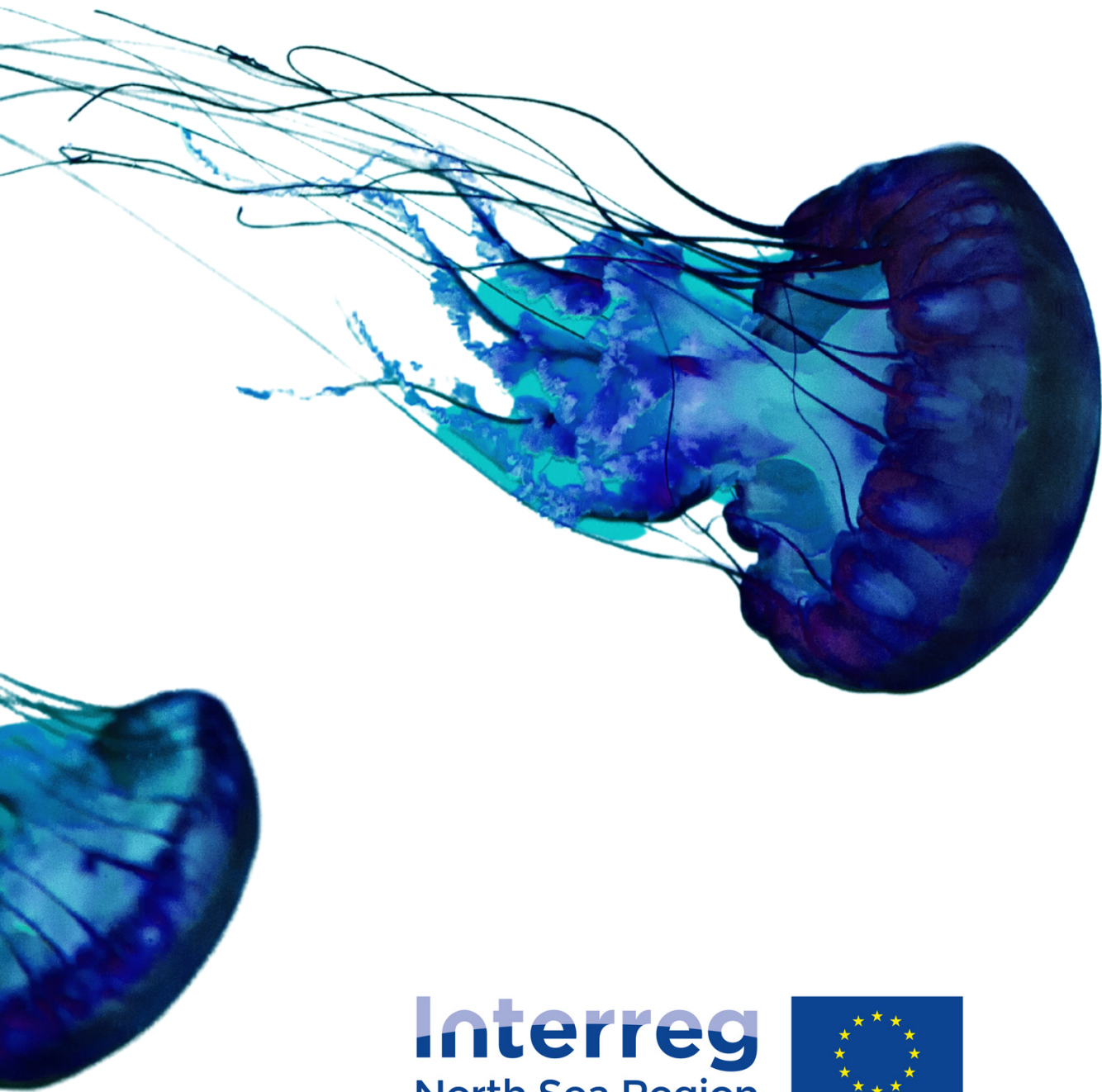
